Covid-19 Parental Agreement

In order to operate safely and to reduce the risk to our staff and children associated with COVID-19 we ask that you follow and agree to these new guidelines. Failure to follow these may result in your child being unable to attend Preschool.

- 1. I will not bring my child/ren to Preschool if they or anyone within our household has or develops a fever, cough, or loss of taste/smell or any symptoms associated with Coronavirus. Or if they are unwell in any way.
- 2. If my child develops any symptoms whilst in setting, I understand I will be called and asked to collect them immediately
- 3. I will provide a packed lunch in a suitable bag/container that will be wipeable and all items in lunch will be suitable for my child to open independently. I will supply all items they require to eat their lunch for example spoons/forks etc.
- 4. I will provide a named wipeable water bottle for my child to use in setting for drinks throughout the day.
- 5. I understand that we need to follow social distancing guidance when waiting to drop off or collect our children from the setting. From the edge of the veranda until further notice.
- 6. Parents/Carers and visitors are not let into the building at this time.
- 7. Only only one parent should attend playgroup for drop off and collection. They will know the password for collecting.
- 8. Additional hand cleaning routines are in place As parents we will do our part in preparing our children for returning to the setting by talking about hygiene, handwashing for 20 seconds, germs and how Playgroup will be different, etc
- 9. No toys from home Please explain this to your child prior to attending. I understand that my child/ren cannot bring any toys from home in order to reduce contamination risks.
- 10. If my child/ren need a comforter I will provide one that can stay at Preschool in order to reduce contamination risks and discuss safe managing of this. Also if they need support to re-settle we will discuss this with the staff so to prevent further distress.
- 11. At Pre-school, All soft toys, fabric cushions and dressing-up material items, etc have been removed.
- 12. Please provide at least 2 items of named clothing in their child's bag prior to attendance (we will store these at pre-school on their pegs plenty of space) to minimize the transmission of Corvid-19 via fabric.
- 13. I will dress my child in clothing that they can manage independently for toileting and self-care needs (nappy changes/personal care will still be done as and when necessary by an adult using P.P.E.)
- 14. At Pre-school we have implemented a rigorous regular cleaning routine consisting of sterilising frequently touched surfaces. This is done at various times during the day and before opening and at the end of day. Please ensure you stick to the arranged drop off and collection times to allow this to happen. [Preschool end of day is currently 2.30pm].

- 15. I understand that socially distancing young children is not possible and by sending my child to playgroup I understand how it is currently operating according to government guidelines reduced numbers of children per day/remaining in these groups with the same staff team every week.
- 16. I understand that social distancing measures are still appropriate outside of Preschool and members of my household will continue to follow Government advice regarding this.
- 17. I will ensure contact details are up to date, that I have informed Pre-school of any changes to health matters/allergies/intolerances/medical needs BEFORE they return.
- 18. Apply SUNCREAM [all day/long lasting] to my child BEFORE they come to playgroup.

In signing this agreement, I understand that I will follow the guidelines above along with Government Guidelines under which Great Gransden preschool playgroup is currently running whilst operating during the COVID-19 Pandemic. Failure to follow these may result in your child being unable to attend Preschool.
